I understand that Kid Innovation College or representatives of Kid Innovation College, District 203, or any employees of District 203 are not responsible for my child after the class adjourns. It is my sole responsibility to provide transportation for my child and supervision for my child immediately following the KIC class. I agree to receive occasional emails regarding future KIC camps. I agree that you may photograph my child during camp and its sponsored events and that you retain the rights to use these visual images for Kid Innovation College's promotional use n other KIC sponsored camps and events without compensation to my child. Kid Innovation College has been created for the focused and excited student who comes ready to learn. Students are respectful of others' personal space, property, and feelings. It is the sole right of Kid Innovation College to remove students from the class if they are inhibiting the learning of others. "I agree to abide and accept any final KIC decisions in terms of preemptively exiting my child from any classes or the Word Warrior Bowl without any benefit of a refund. Additionally, I and my child will accept all rules, protocols, procedures, and final scoring values determined by KIC staff members and/or Word Warrior judges no matter what and understand that those decisions are final, undebatable, and are made with the best intentions in creating the most appropriate outcomes possible despite my possible personal reservations." **In addition, the signer of this document understands that a cancellation fee of \$40 is in effect for any cancellations after March 1st and zero refunds will be given out for summer courses after May 1st, although the signer will have the option of applying a 70% credit (rounded to the nearest available dollar) to next year's KIC courses if they wish based on what they paid for the current year.
